

## PRIVACY POLICY

This Privacy Policy was last updated on July 17, 2024

Geoswift Limited and its subsidiaries and affiliates ("Geoswift", "we", "us", "our", and similar terms) respects your privacy and values the confidence of its customers, partners, and employees. This Privacy Policy explains, among other things, the types of information collected about you when you visit Geoswift sites http://www.geoswift.com/ and https://www.paytuitionnow.com/ (the "Websites"), how your information may be used and when it may be disclosed, how you can control the use and disclosure of your information, and how your information is protected.

Geoswift complies with the data protection principles and all relevant provisions of the Hong Kong Personal Data (Privacy) Ordinance and General Data Protection Regulation (GDPR) in the EU and Data Protection Act 2018 in the UK. In doing so, we will ensure that all Geoswift employees and third party service providers/partners involved in handling personal data comply with appropriate standards of security and confidentiality.

This Privacy Policy applies to Geoswift Websites, as well as any online services that link to this Privacy Policy (the "Services"). Please read the entire Privacy Policy before using our Services. By using the Services, you agree to abide by the terms of this Privacy Policy.

## 1. Personal Information Collection

## Nature and Purpose of the Collection

In order to carry out some of our Services, we may collect the following personal information from you on one or more of our Websites covered under this Privacy Policy:

- Payment information for transfer of funds on https://www.paytuitionnow.com/, including payment reference number, name, student id, national id number, email address, phone number, and date of birth.
- Your email address, physical address, company name and telephone number.



In addition, we may also collect the following third party personal information from you, should the identity of the payer be different from the student, as part of our transfer services offered on <a href="https://www.paytuitionnow.com/">https://www.paytuitionnow.com/</a>

- Third party's Chinese name
- Third party's China National ID number
- Third party's China phone number

We will use those data to conduct necessary checks including but not limited to checks for AML and verification purposes and help to improve its internal system and carry out further revision of company terms and conditions, also including to:

- 1. Processing various service applications, including financial services requested on https://www.paytuitionnow.com/;
- Provide you with the products, promotions, services, newsletters, and information you request and respond to correspondence that we receive from you;
- 3. Maintain or administer the Services, perform business analyses, or for other internal purposes to improve the quality of our business, the Services, and other products and services we offer;
- 4. Contact you via email and otherwise about products, services, and events that we believe might be of interest to you;
- 5. Customize and personalize your use of the Services; and
- 6. As otherwise described to you at the point of collection or pursuant to your consent.

## Sharing of Information

We are committed to maintaining your trust, and we want you to understand when and with whom we may share the information we collect. Again, we will not sell your personal information to any third parties.

We may share some or all of your personal data with the following parties and for the following purposes:

- Corporate Parents, Affiliates, and Subsidiaries. We may share your information
  with our subsidiaries and other affiliated entities for a variety of purposes,
  including for business and operational purposes.
- Service Providers. We may share your information with service providers that perform certain functions or services on our behalf (such as to host the services or manage databases). These third parties are authorized to use your personal information only as necessary to provide these services to us.
- Sub-contractors or sub-processors for the performance of any contract Geoswift enter into with them or the Company.
- Various government agencies and/or officials as required by law or as necessary to protect our business and services. We may disclose your information to third parties in order to protect the legal rights, safety, and

security of Geoswift and/or any of our affiliates and subsidiaries, and the users of our Services, including sharing data and information within Geoswift or its related associates and/or any other use of data and information in accordance with any group-wide programs for compliance with sanctions or prevention or detection of money laundering, terrorist financing or other unlawful activities; investigate fraud, enforce our Terms of Use; prevent fraud (or for risk management purposes); and comply with or respond to law enforcement, legal process or a request for cooperation by a government or other entity, whether or not legally required.

- In Connection with a Transfer of Assets. If we sell all or part of our business, or make a sale or transfer of assets, or are otherwise involved in a merger or business transfer, or in the event of bankruptcy, we may transfer your information to one or more third parties as part of that transaction. You will be notified via email and/or prominent notice on our Website of any change in ownership or uses of your personal information, as well as any choices you may have regarding your personal information.
- Banking partners.
- Other Parties with Your Consent. We may share information about you with third parties when you consent to such sharing or as required by law, including when you post information to a user profile or a public area of the Services, such as a chat room, forum, blog, or other community tool.

Any disclosures in connection with requirements of the law or as necessary to protect the services, the obligations and/or requirements shall stem from the following basis:

- Any law binding or applying to it within or outside the Hong Kong Special Administrative Region existing currently and in the future;
- Any guidelines or guidance given or issued by any legal, regulatory, governmental, tax, law enforcement or other authorities, or self-regulatory or industry bodies or associations of financial services providers within or outside the Hong Kong Special Administrative Region existing currently and in the future;
- The data that Geoswift collect from the client, partner or vendors may also involve transfer of those personal data to any country, including countries outside the European Economic Area, but that in those cases, except where the relevant country has been determined to ensure an adequate level of data protection by the European Commission or Geoswift need to make the transfer in order to perform a contract concluded in interests of the data suppliers or relevant party, Geoswift will ensure that the transferred personal data is protected by a data transfer agreement in the appropriate standard form approved for this purpose by the European Commission or by a binding legal agreement (and that further details of these transfers and copies of these agreements are available from Geoswift on request). It may also be processed by Geoswift's staff operating outside the EEA who work for Geoswift. Such staff maybe engaged in, among other things, the fulfilment of the Company's order, the processing of the Company's payment details and the provision of support services. By submitting the Company's personal data, the Company agree to this transfer, storing or processing.

## 2. Use of Cookies, Log Files and Other Tracking Technologies



## <u>Cookies</u>

Cookies are small data files which are placed on data subject's device when data subject visit certain parts of Geoswift's Website or click on Geoswift's online advertisements.

Cookies and similar technologies are used to identify data subject's device for the following purposes:

- 1. Essential cookies. These essential cookies are set throughout Geoswift's Website and are required for the operation of the Website to:
- allow Geoswift's web server to determine whether the cookies setting on data subject's web browser has been enabled or disabled. This allows Geoswift to know whether data can be collected from data subject's web browser;
- temporarily allow data subject to retain certain information/preferences between pages of Geoswift's Website to avoid having to re-enter that information;
- temporarily identify data subject's device after data subject has logged in to a secure page on Geoswift's Website so that Geoswift's web server can maintain a dialogue with data subject's web browser in order for data subject to carry out certain activities.
- Analytical/performance cookies. These are used to help Geoswift improve Geoswift's Website by tracking data subject's visits to Geoswift's Website and recognizing data subject's web browser when data subject is repeat visitor so that Geoswift can gather statistics on new and repeat visitors to evaluate site effectiveness.
- 3. Functionality cookies. These are used to recognize data subject when data subject return to Geoswift's Website. This enables Geoswift to:
- personalize content for data subject and remember his/her preferences (for example, choice of language and region);
- store his/her login and other preferences so he/she does not have to reenter that information when he/she returns to Geoswift's Website.
- 4. Targeting / Advertising cookies. These cookies record data subject's visits to Geoswift's Website, his/her response to Geoswift's online advertisements, track the pages he/she have visited and the website links he/she have followed. Geoswift use this information to:
- make Geoswift's Website more relevant to data subject's interests;



- provide online advertisements or offers on Geoswift's Website or third-party websites which are most likely to interest he/she;
- evaluate the effectiveness of Geoswift's online marketing and advertising programs.

The above cookies may be placed on data subject's device by Geoswift or by third parties on Geoswift's behalf (for example, advertising networks and providers of external services like web traffic analysis services). Our third party partner may use technologies such as cookies to gather information about your activities on this site and other sites in order to provide you tailored advertisements based on your browsing activities and interests. ## Log Files and Other Tracking Technologies

As true of most websites, we gather certain information automatically and store it in log files. This information may include internet protocol (IP) addresses, browser type, internet service provider (ISP), referring/exit pages, operating system, date/time stamp, and/or clickstream data. We do not link this automatically collected data to other information we collect about you.

In addition to cookies, technologies such as beacons and scripts are used by Geoswift and our third-party service providers who may use these technologies to collect information that helps us with traffic measurement, research, and analytics. We will use these types of technologies to analyze trends, administer the sites, track users' movements throughout the sites, and to gather demographic information about our user base as a whole. We may receive reports based on the use of these technologies by these companies on an individual as well as aggregated basis.

Encryption technology is employed for sensitive data transmission.

As a result, while we strive to protect your information and privacy, we cannot guarantee or warrant the security of any information you disclose or transmit to us online and cannot be responsible for the theft, destruction, or inadvertent disclosure of your information. ## 2.Cookie、日志文件及其他追踪技术的使用

## Cookie

Cookie 是指在数据主体访问 Geoswift 网站的某些部分或点击 Geoswift 的在线 广告时在数据主体的设备上放置的小型数据文件。

我们使用 Cookie 和类似技术识别数据主体的设备,并用于以下目的:

- 1. 基本 Cookie。整个 Geoswift 网站均设置了这些基本 Cookie,网站的操作需要使用这些 Cookie,从而:

## 6.未成年人
